

SPECIAL RULES FOR CONDUCT OF SUMMER 2020 EXAMINATIONS OF FAILURE STUDENTS OF ALL SEMESTERS AND EXTERNAL STUDENTS, DIRECTION,2020.

Whereas, the Maharashtra Public Universities Act (the Act) regulates the governance of the public Universities including the Rashtrasant Tukadoji Maharaj Nagpur University (the University) in the state of Maharshtra;

AND

Whereas, sections 48 and 33 of the Act empowers the Board of Examinations and Evaluation and the Academic Council of the University ,respectively, to take decisions and devise strategies in respect of conduct of examinations and evaluation of various academic programmes in the University, leading to award of certificate, diploma, advanced diploma or degrees of the University and the Academic Council is empowered to frame appropriate Ordinances in this regard;

AND

Whereas, section 8 of the Act empowers the state government to issue directions to the University, in certain circumstances which in the opinion of the state government justifies it to issue such directions, to carry out its functions by the University;

AND

Whereas, the outbreak of the global pandemic of Covid-19 has created natural calamity of unprecedented nature, badly affecting all the sectors of human

activities including the education sector in India, and posing unforeseen challenges to the systems which were created in anticipation of existence of certain ideal situation;

AND

Whereas, the outbreak of the pandemic forced the governments to declare lockdown throughout the state and the nation prohibiting free movement of the people, disrupting the teaching, learning and all the activities related to conduct of examinations by the Universities in the state of Maharashtra including Rashtrasant Tukadoji Maharaj Nagpur University;

AND

Whereas, due to lockdown several students of the University are stranded at various places outside the University making it difficult for them to appear for the examination conducted in the normal method on one hand and undesirable on part of the University to conduct the examinations in the traditional way due to health hazards associated with this method;

AND

Whereas, the extraordinary situations demands some out of Box thinking and planning so that human life does not come to standstill and that it moves forward and keeping this principle in mind the University Grants Commission and the State Government have issued guidelines from time to time with respect to the measures to be taken in managing the present crisis in the education sector, due to the pandemic;

AND

Whereas, majority of the summer 2020 examinations, both the theory and practical, of the University were disrupted due to the pandemic and the lockdown;

AND

Whereas, conduct of the examinations by the University in the normal way as per the existing rules and regulations under the Ordinances/Statutes/Directions/Regulations of the University is yet not possible in view of the risk to the health of the students, teachers and the non-teaching staff;

Whereas, keeping in mind the interests of the students some innovative method was required to be devised to protect the interest of the students so that they do not loose precious academic year of their life and also to maintain the sanctity of the examinations Direction No. 12 of 2020 and 20 of 2020, based upon decisions of various committees and the Authorities of the University were issued, governing the conduct of examinations and declaration of results of the students of the final year/final semester of various programmes excluding the external students, and preparation of results and promotion of regular and ex-students of even semesters of various programmes who were to appear for the summer 2020 examinations and also for their promotion to higher semesters;

Whereas, the supplementary examinations of odd semesters of various programmes, which were to be conducted in summer 2020, either were partially conducted or were abandoned due to sudden declaration of the lockdown by the governments;

Whereas, the issue of conduct of those examinations which were to be held in summer 2020 and which were not covered by either Direction No. 12 of 2020 or 20 of 2020 was pending in the University;

AND

Whereas, the Academic Council in its meeting dated 29/10/2020 vide item no. 79 and the Management Council in its adjourned meeting held on 10th November 2020 vide item no. 165 have accorded their approval for conduct of the final year/ final semester examinations of the LL.M. (External); M.A.(External); and B.A.(External) programmes for which summer 2020 examinations could not be conducted, in the same manner in which the examinations of the final year/final semester of other programmes were conducted by the University as per the provisions and scheme of Direction No. 20 of 2020. Similarly, the Academic Council and the Management Council have granted their approval for conduct of examinations of failure students of all the previous years/previous semesters of all the programmes for which examinations could not be conducted by the University either wholly or partially in Summer 2020, in the same manner in which examination for the backlog papers of the students of the final year/final semester of various programmes were conducted at the college level as per the provisions of Direction 20 of 2020 and 12 of 2020;

AND

Whereas, the Committee constituted by Hon'ble Vice-Chancellor under the chairmanship of Pro-Vice Chancellor and all the four Deans as members and the Director, Examinations and Evaluations as a member secretary in its meeting dated 23/11/2020 has submitted a report spelling out a detail action plan for conduct of the remaining examinations of summer 2020 i.e. those examinations which are not covered by the provisions of Direction No. 12 of 2020 and 20 of 2020;

AND

Whereas, to implement the decisions of Management Council and the Academic Council and the action plan suggested by the special committee under the chairmanship of the Pro Vice-Chancellor, suggesting a departure from the normal mode of conduct of examinations as prescribed by the governing Ordinances/Directions of the various academic programmes in the University, an Ordinance is required to be made but since making of an Ordinance is a time consuming process and there is exigency to conduct examination of the students as per the above mentioned recommendations, a Direction under section 12 (8) of the Act is required to be issued;

Now, therefore, I Dr. Subhash R. Chaudhari, Vice Chancellor of the University, in exercise of my powers under section 12 (8) of the Act do hereby issue the following Directions.

1. This Direction shall be known as " SPECIAL RULES FOR CONDUCT OF SUMMER 2020 EXAMINATIONS OF FAILURE STUDENTS OF ALL SEMESTERS AND EXTERNAL STUDENTS, DIRECTION,2020.

2. This Direction shall come in to force from the date of its issuance.

3. In this Direction unless the context otherwise requires:-

i. College: College means and includes an affiliated and conducted college/institution/department of the University.

ii. "Lockdown" means the lockdown declared by the central and state governments prohibiting the free movement and gathering of the people for any purpose except the permissible purpose notified by the governments.

iii "Pandemic" means the pandemic of the disease spread by the Covid-19 virus.

iv "Programme" means any academic programme consisting of one year/two semesters or more years/semesters, comprising one or more subjects, leading to the award of the certificate/diploma/degree of the University.

v. "University" means Rashtrasant Tukadoji Maharaj Nagpur University.

4. Notwithstanding anything to the contrary contained in any Ordinance, Statute, Direction and Regulations and especially the Ordinance No.9 of 1973 and Direction No. 10 of 2019, except to the extent the provisions of the said Ordinances/Directions have been retained, this Direction shall govern the conduct of Summer 2020 examinations and declaration of their results .

5. Scope:-

- i. This Direction shall **not apply** to the regular students of the odd semesters of all the programmes who have taken admission in the academic year 2020-21. Notwithstanding anything to the contrary herein the benefit of this Direction shall also not be available to students of B.A. (Additional) programme.
- ii. It shall apply to :
 - a) All the students who were to appear for the supplementary examinations of odd semesters of all the programmes which were to be conducted in summer 2020, including the students whose examination was partially conducted before declaration of the lockdown.
 - b) All the external students of the final year/final semester of the LL.M;M.A; and B.A. programmes.
 - c) All students of B.P.E. 1st Year; B.A. (Mass Communication) 1st Year; Master of Labour Studies 1st Year; B.Sc. (Forensic Science) and M.Sc. (Forensic Science), B.Voc. programmes admitted in the academic year 2019-20, notwithstanding the delayed admission of B.Voc. students.
 - d) All the ex and regular students of 1st to 5th semesters of B.A. (External) programme and 1st to 3rd semesters of M.A.(External) programmes.

- e) All the ex -students of odd and even semesters of all programmes excluding external students.
- f) All the students of final semester/final year of various programmes who could not appear for the examination, for whatever reason, conducted as per the provisions of Direction No. 20 of 2020.
 Explanation:- In order to be eligible to appear for the examination conducted under this Direction the student should have filled the examination form and paid the requisite fee for the summer 2020 examination. No student who had not filled such examination form shall be allowed to fill the examination form for appearing in the examination even by paying any late fee.
- 6. The examination of the students of the final year/final semester of LL.M.(External); M.A. (External); and B.A. (External) shall be conducted by the University in the online mode as per the provisions of and scheme under Direction No. 20 of 2020.
- 7. The examinations of all the students of all the programmes falling under para 5 except the students covered under para 6 above and the students covered under para 8 below a well as the final semester/final year students of all other programmes shall be conducted by the colleges in the off line, online, or mixed mode as per the provisions of and the scheme under Direction No. 12 0f 2020 and 20 of 2020 dealing with conduct of examinations by the colleges.
- 8. The results of the students of B.Sc. (Forensic Science) 2nd and 4th semesters shall be prepared on the basis of their average marks in the examinations of 1st and 3rd semesters respectively irrespective of the fact whether the results of 1st and 3rd semesters pertains to the Winter 2019 or earlier examination, Similarly the results of the students of the 2nd semester M.Sc, (Forensic Science) programme shall be prepared on the basis of the average marks secured by these

studenst in the examination of their first semester. Where the students of the 1st and 3rd semesters of the B.Sc. (Forensic Science) programee or the 1st semester of the M.Sc. (Forensic Science) programme had not appeared in those examinations in winter 2019 or earlier examinations but had applied for those examinations in summer 2020 the examinations of such students shall be conducted by their colleges and the results of their 2nd or 4th semester shall be declared subsequently as per the formula herein.

- 9. In any programme/course if any subject carries grade instead of marks then the evaluation of such subject shall be done by the internal subject expert in the concerned college/institute and the evaluation report by way of award of the grades of the students shall be submitted by the concerned college/institute to the University in the usual mode of submission of the confidential documents immediately.
- 10. If any student is not satisfied with the result declared under these rules and wish to improve his grades such student shall have the option to refuse the result and opt for the university examination during next semester, as and when the same is conducted by the University. However, this option shall be exercised by the student within 15 days from the declaration of the result under this Direction through the Principal/Director/Head of the college/institute of which he/she is a student. The opinion exercised by the students shall be submitted by the Principal/Director/Head of the college/institute/department within five days after the last day for the submission of the option by the students.
- 11. In those programmes/courses where internal/theory examination is conducted at the college/institute level only without there being assignment of any other college/institute as an examination centre the examination shall be conducted by the concerned college/institute in offline/online/mixed mode following the norms

of social distancing, wearing of mask, hygiene etc. prescribed by the concerned authorities from time to time, at the earliest and submit the marks to the University.

- 12. No student who has availed the benefit of the special rules under this Direction shall be entitled to seek revaluation/reassessment of any of the answer books of the examination conducted under this rules. The result shall be final and binding on the students.
- 13.Notwithstanding anything to the contrary in any ordinance/statute/Direction/Regulation in existence in the University, where a student covered by Clause 5 (ii) (f) appears for an examination conducted under this Direction his earlier result shall be altered by entering the marks and a note to that effect be made in the tabulation register.
- 14. In the event of any difficulty arising in the declaration of results as per this Direction or the question of interpretation of the provisions of this Direction arising the matter shall be referred to the below mentioned committee whose decision shall be final:-

Pro -Vice-Chancellor – Chairman,

Deans of all the four faculties, - Members

Director, Examination and Evaluation – Member Secretary.

Note:- If for any reason Pro-Vice-Chancellor is not available or is not able to attend the meeting of the committee the Dean of the faculty of Science and Technology shall preside as the chairman of the committee.
