Whereas the Party No. 1, a respected leader in the medical devices industry, through its educational initiative HITI is engaged in the activity of providing industry-focused trainings and research facilities to students and working professionals of certain medical and paramedical domains and has the mandate and power to establish linkages with national and international bodies and institutions for the purpose of enhancing and expanding the quality of education and research.

Now, therefore, this Memorandum of Understanding witness as below:

- The broad objectives of the MoU shall be as follows:

- 5. Validity: 36 month from date of contract.
- Role and Responsibilities of HITI: To train students of Party No. 2 with a mutually agreed course curriculum at mutually accepted prices before the launch of the particular training program.

- 7. Role and Responsibilities of (Party No. 2): To nominate students who are interested to train with Party No. 1, and, if special needs of any students, verify them and inform it in writing to Party 1 and take a prior acceptance in writing.
- 8. **Joint Responsibilities:** Joint Responsibilities of Party No. 1 & 2: Safety and security, regular attendance and good behavior of nominated students for the duration of the course.
- **9. Financial Arrangements**: Course fees and advance payment terms to be decided prior to acceptance of course between two parties

Reasonable time to be given for discussion and closure of fees and other financial terms

10. Monitoring Committee:

For the smooth, effective, and transparent implementation of the project there shall be monitoring committee comprising the following persons:-

- (i) President, HORIBA India Pvt Ltd
- (ii) Principal and/or Project Director, HITI
- (iii) Representative of Party No. 2
- (iv) Head of the institution of Party No. 2 (Member Secretary)

The monitoring committee shall meet physically or digitally at least once in six months and finalize various plans & reports pertaining to implementation of the project. It shall also review the financials and discuss any other item with permission of the monitoring committee. The decision of HORIBA India President will be the deciding factor in the above matters between the two parties.

11. Publications or other benefits out of MOU

- All publications in the programs of cooperation will be co-authored by the concerned staff and faculty of HITI and Party 2. The Monitoring Committee shall review the patentability aspect of any research work carried out under this MOU and decide whether an application for patent can be made or not.
- HORIBA and Party 2 will be joint holders of the intellectual property rights (IPR) arising out of the joint work. The decisions on ownership, licensing, costs, royalties, etc. shall be discussed and made by the Monitoring committee.

12. Waiver (if any)

The waivers by either party of a breach or default of any of the provision of this MoU by the other party shall not be interpreted as:

- A waiver of any succeeding breach of the same or other provisioner shall any delay or omission on the part of either party to exercised; or
- A way to avail itself of any right, power, or privilege that it has may have under this MoU to operate as a waiver of any breach of default by the other party.

13. Termination of MoU

 The MoU can be terminated by either Party giving to the other party a prior written notice of not less than 60 days of its intention to do so but without dishonoring any commitment entered in to prior to the date of termination of the notice.

15. Arbitration

Jamdar Siemens Center of Excellence hereinafter called the "VRJSCOE" established and operational at Visvesvaraya National Institute of Technology Nagpur, a premier technical Institution of National Importance incorporated under National Institute of Technology Act. 2007 having its permanent campus and office at Nagpur (hereafter referred to as 'VNIT Nagpur' which expression shall include its successors and assigns) of the first part;

And

Dharampeth M. P. Deo Memorial Science College, Nagpur hereinafter called the "**DMPDSVM**" (which expression shall unless repugnant to the context or meaning thereof be deemed to mean and include its successors and assigns) of the second part;

WHEREAS:

- 1. The Visvesvaraya National Institute of Technology Nagpur, an Institution of National Importance (formerly known as Visvesvaraya Regional Engineering College) was started as a joint and co-operative venture of the Government of India and the Government of Maharashtra in 1960 with a view to catering to the needs of man-power in technology for the country. The college has been conferred with autonomy in financial and administrative matters to achieve rapid development. Because of this rich experience, this institution was granted Deemed University Status with the approval of the UGC/AICTE and Govt. of India in the year 2003 and renamed as Visvesvaraya National Institute of Technology, thereafter.
- 2. VRJSCOE established in 2020 at VNIT Nagpur premises with investment from Siemens and VNIT Nagpur as per the Guidelines for Center of Excellence issued by Ministry of Education, Government of India. The VRJSCOE operates with a primary objective of creating a robust technical education eco-system through its experience in industrial products and services This VRJSCOE is intended to bridge gap between industry requirements and technical education, and provide solution that makes technical institutes

6. Details of MoU

The VRJ Siemens CoE and VNIT Nagpur, India enters into the following Agreement to offer Skill Development, Training and other related services to **DMPDSVM**, **Nagpur**

- 10. The implementation of specific activities will be separately agreed between both institutions on need basis.
- 11. Other terms and conditions which are not provided in this Agreement will be deliberated and agreed upon by the institutions hereto.
- 12. This Agreement is established in English language and is valid from the date of signing by the representatives of the institutions. The institutions hereto have executed this Agreement in duplicate, and each institution shall keep one copy of the originals.
- 13. This agreement shall be governed by and construed in accordance with the laws of India. Any dispute arising under these terms and conditions shall be subjected to the jurisdiction of the courts of Nagpur.
- 14. The two parties will consult each other and attempt to resolve disputes or misunderstandings that arise in the administration of this agreement informally.

15. This agreement shall be valid for a period of three years from the date both signatures are affixed to this document or before if terminated by mutual agreement of both. This agreement may be terminated by either party after one hundred and twenty (120) days following receipt of a written notification of intent to terminate by the other party.

Scope and Terms of References for setting up the same shall be as under:

SCOPE OF PARTIES

SCOPE OF RCNBG & RCNDT

- 1. RCNBG & RCNDT SHALL PROVIDE 13 Sewing Machines of SINGER Make of different models as per the list provided. However, ownership of the said Machines shall be with RCNBG & RCNDT and the machines will be insured properly by RCNBG & RCNDT
- 2. RCNBG & RCNDT shall arrange for Singer Authorised Trainers from 10.30 am to 12.00 pm on all weekdays -Monday to Friday, except National and Regional Holidays.
- 3. RCNDT shall be the single point contact for all queries related to functioning of the institute for the College in Co-Ordination with RCNBG
- 4. RCNBG Will Provision for appropriate renumeration to SINGER Authorised Trainer.

SCOPE OF DHARAMPETH M.P.DEO MEMORIAL SCIENCE COLLEGE

- 1. COLLEGE shall provide adequate premises to conduct the training programmes.
- 2. All requisite Fixtures and Furniture shall be provisioned by the college.
- 3. All Operating Expenses, except maintenance of the Sewing Machines, shall be borne by the COLLEGE.

- 4. ALL Consumables required for running the Machine like Needle, Thread, Cloth, etc shall be borne by the COLLEGE.
- COLLEGE, at their discretion, may provide service of Stitching and Supplying Cloth Bags to ROTARY; wherein ROTARY Shall pay an honorarium of Rs.1/- Per bag to the COLLEGE.
- Any other engagements with ROTARY related to such commercial activities (mentioned in Item No. 5 above) shall be mutually decided between the parties with the sole aim pf providing support to the needy.
- 7. COLLEGE shall pay Rs.100/- Per Candidate Per Month to RCNBG through Cheque/Demand Draft/EFT to RCNBG Bank Account on Monthly Payment basis for three months/ for duration of the certificate course. However, in view of the academic schedule and examination patter college is entitled to spread the three months training beyond three months' time if required.
- The college shall be entitled to use the machines for regular course work or six months diploma course for the students under the guidance of trainer if required.
- All Training Completion Certificates awarded by the COLLEGE shall invariably have RCNBG and RCNDT's name on the CERTIFICATE.

DISPUTE REDRESSAL

- Any dispute arising out of this agreement shall be resolved amicable by the parties involved. No Court Of Law WILL be involved by either parties under any circumstances whatsoever of any nature.
- TERMINATION: Either Party can terminate the contractual obligation by giving minimum 3 Months notice or as agreed mutually. In such case RCNBG and RCNDT Shall have the right to take back the Sewing Machines provided.
